The Structure of Finite Verb Clauses in Dhivehi Complex Sentences: A Corpus Analysis

ABSTRACT *The identification of finite verbs, finite verb clauses, sentences, and sentence structures presents numerous challenges and remains the subject of ongoing academic debate. While some languages follow a Subject-Verb-Object (SVO) order, others, such as those with a Subject-Object-Verb (SOV) structure, are categorised as verb-final languages. Word order differs across languages in other ways as well. A simple sentence consists of an independent clause containing a subject and a predicate. In contrast, complex sentences are formed by combining one or more dependent clauses with at least one independent clause. This study aims to examine the structure of finite verb clauses within complex sentences in Dhivehi, specifically focusing on the syntactic changes that occur when clauses are combined and the roles of these clauses in the overall sentence structure. The research adopts a corpus linguistics methodology, utilising data from two distinct corpora: one comprising 2,600 sentences from literary and academic writings spanning from 1950 to 2022, and the other consisting of over 10,000 sentences extracted from the 'Faththoora' magazine. The sentences from the first corpus were manually tagged in a Microsoft Excel spreadsheet, and finite verb clauses were identified using Excel's filter tool. To support the analysis, further examples were extracted from the second corpus where needed. The collected clauses were then grouped, tabulated, and analysed based on their syntactic structure and functional roles within the complex sentences. The primary finding of this study is that finite verb clauses in Dhivehi complex sentences predominantly appear as independent clauses placed at the end of the sentence. Additionally, 11 distinct types of dependent clauses were identified, which can function as subjects or objects of finite verb clause. The study further reveals that dependent clauses can be used in various ways, such as to express reasons, function as adverbials, adjuncts, indicate reported speech and clause chaining. These findings have important implications for linguists, educators, and those involved in the study or use of written Dhivehi. By outlining the syntactic principles and rules governing the use of finite verb clause and dependent clauses in Dhivehi complex sentences, this study provides valuable insights for both theoretical research and practical application in language teaching.*
